Property Tax Call To Action!

The current 7% Homeowners Property Tax Exemption Cap expires next year. TRAC's (Tax Reform Action Coalition) goal is to get the 7% cap extended in time to limit how much our assessments will increase with the upcoming triennial reassessment in 2006 and to work for more substantial property tax reform for all property owners.

Assessor James Houlihan sent a bill (SB700) down to Springfield that provides for the 7% cap to be made permanent and to

remove the ceiling of \$20,000 (remove the "cap on the cap.") This bill, SB700, has the support of Mayor Daley.




Halloween Invasion from Space Monday!
